Dear Sri Srivastava ji

Seventh State Law Commission had submitted its first report on 09.11.2017 recommending the repeal of 1,166 useless and dead enactments.

The Commission in its previous report had not considered the Appropriation Acts since 1950 till date for the reasons that those Appropriation Acts were passed for a particular financial year. The Commission had given its second thought on the point that the Appropriation Acts which are the part of statute book are now of no use because the provisions of such Appropriation Acts (including Supplementary Budget and Vote on Account Acts) were relevant for the particular financial years with a view to make provisions for revenue and expenditure. Accordingly the Commission has prepared a list of Appropriation Acts (including Appropriation Supplementary and Vote on Accounts Acts) since 1950 till 2014 and has excluded the Appropriation Acts and Acts relating to Vote on Account which have already been repealed by U.P. Act No. 10 of 2018.

I am glad to submit herewith the Second Report of Seventh State Law Commission along with new Fourth Schedule with the request to include the Acts mentioned in the Fourth Schedule in the Proposed Repealing Act, 2018. In the previous report, Three Schedules were mentioned and the Acts mentioned along with this report may be made part of the new Fourth Schedule. In the alternative, a separate Bill regarding Appropriation Acts may be placed before the House, of which Draft Bill is also enclosed herewith.

SECOND REPORT OF VIIth STATE LAW COMMISSION OF U.P.

The Seventh State Law Commission undertook the task of scavenging the obsolete and unuseful Acts of the State and submitted its first report on 09.11.2017 for repealing 1,166 unuseful and obsolete Acts. In the previous report, the Commission had not considered the repeal of Appropriation Acts of the State. The Law Commission of India had already recommended for repeal of Appropriation Acts enacted since 1950. Consequently, the Parliament has enacted ‘THE APPROPRIATION ACTS (Repeal) Act, 2016 (Act No. 22 of 2016) The State Legislature enacts the Appropriation Acts for a particular financial year and relevance of such Appropriation Acts is lost when the next Appropriation Act in the next financial year is passed.

The Law Commission of India in its Ninety Sixth report observed as follows:-

“Accordingly, every legislature is expected to undertake what may be called the periodical spring-clearing of the corpus of its Statute Law in order that dead wood may be removed and citizens may be spared of the inconvenience of taking notice of laws which have ceased to bear any relevance to current conditions. This process in itself assumes still greater importance in modern times when Statute Law is growing in bulk and magnitude...”

Sixth State Law Commission headed by Justice V.C.Misra had submitted its Ninth Report-2011 regarding repeal and amendments of certain Uttar Pradesh Acts. Prior to it an extensive exercise was done by Justice K.N.Goyal Commission in its Eleventh Report submitted in October, 2001 but in those reports too, the Appropriation Acts were not taken into consideration. As mentioned in the earlier report, no further steps were taken by the then State Governments to implement these reports.

It is learnt that the present Government is seriously considering the first report of 7th State Law Commission which gave strength to the Commission to identify more such Acts which have become obsolete.

In the present report, the Commission has considered the Appropriation Acts since 1950 till 2014. It is also relevant to mention that by Uttar Pradesh Repealing Act, 2017 (U.P. Act No. 10 of 2018), apart from two other Acts, 13 Uttar Pradesh Appropriation Acts have already been repealed most of which were Vote on Account Acts. Therefore, the Commission has not included those Acts which have already been repealed by Act No. 10 of 2018. Acts which are proposed to be repealed by the present report have been mentioned in Schedule appended to this report called Fourth Schedule. This Fourth schedule may be made part of the first report of this Commission upon which Repealing Bill is proposed to be laid before the Legislature. In the alternative, separate Bill regarding Appropriation Acts may be placed before the House. If the

Legislative Department, Govt. Of U.P. takes a decision to place independent Bill, then the draft bill is also enclosed herewith.

UTTAR PRADESH APPROPRIATION ACTS (REPEAL) BILL 2018

BILL

to repeal Appropriation Acts

It is hereby enacted in the Sixty-ninth Year of the Republic of India as follows :-

Short title and commencement

1 (1) This Act may be called the Uttar Pradesh Appropriation Acts (Repeal) Act, 2018.

(2) It shall come into force at once.

Repeal of Certain enactments

2. Subject to the provisions of sections 6, 6-C, 7 and 8 of the Uttar Pradesh General Clauses Act, 1904, the enactments specified in the Schedule, are hereby repealed.

Savings

3. The repeal by this Act of any enactment shall not affect any other enactment in which the repealed enactment has been applied, incorporated or referred to;

and this Act shall not affect the validity, invalidity, effect or consequences of anything already done or suffered, or any right, title, obligation or liability already acquired, accrued or incurred, or any remedy or proceedings in respect thereof or any release or discharge of or from any debt, penalty, obligation, liability, claim or demand, or any indemnity already granted or the proof of any past acts or things;

nor shall this Act affect any principle or rule of law, or established jurisdiction, form or course of pleading, practice or procedure, or existing usage, custom, privilege, restriction, exemption, office or appointment, notwithstanding that the same respectively may have been in any manner affirmed, recognized or derived by, in or from any enactment hereby repealed;

nor shall the repeal by this Act of any enactment revive or restore any jurisdiction, office, custom, liability, right, title, privilege, restriction, exemption, usage, practice, procedure or other matter or thing now existing or in force.
